CALL TO ORDER

#### Roll Call

President Jacobson called the Regular Board Meeting to order at 6:09 pm. The roll was called and Commissioners Bragg, Drazner, Jacobson, Johnson and Reiner answered present.

#### APPROVAL OF REGULAR BOARD MEETING AGENDA

#### GREEN INFRASTRUCTURE PROJECT REVIEW

Jeff Weiss, with EAT, gave a presentation to be Board on Green Infrastructure in Buffalo Grove. Jeff and Dan Anderson, Crew Chief of the Buffalo Grove Park District, defined green infrastructure, highlighted the team's accomplishments over the last year, and outlined their goals for 2019. President Jacobson commended the group on their work and said that what they do affects not only our community, but other communities as well.

# Resolution 19-2-1 Commemorating Buffalo Grove Environmental Action Team's 10<sup>th</sup> Anniversary

WHEREAS, the Buffalo Grove Environmental Action Team, hereafter referred to as BG EAT, is a dedicated group of environmentally conscious local citizens, eager to improve the community's natural environment, and encourage sound and sustainable practices since the group organized on February 18, 2009;

WHEREAS, the BG EAT sponsors an annual Plant the Park event to establish native trees and plants to restore prairies, woods and wetlands in our parks. The team organized an exhibit and a series of events at the Raupp Museum to honor our natural heritage and surviving prairie remnants;

WHEREAS, for the last six years the BG EAT has sponsored a Green Fair in June. It features educational booths and opportunities to recycle a wide variety of household items. More than 300 bicycles have been donated to Working Bikes Cooperative at this event. BG EAT members also served on the Village bicycle commission.

WHEREAS, the BG EAT brought recycling to Buffalo Grove Days and organized their first electronics recycling event on April 25, 2009. The group currently works at the annual recycling event in conjunction with the Village of Buffalo Grove and SWANCC;

WHEREAS, the BG EAT promotes alternative energy and worked with the Village of Buffalo Grove to implement the electrical aggregation program that purchased 100% green energy for Village residents for three years;

WHEREAS, BG EAT members founded the Buffalo Creek Clean Water Partnership and conduct annual water quality assessments in Buffalo Creek;

WHEREAS, BG EAT formed an Adopt-a-Highway team and organizes annual stream cleanups along Farrington Ditch;

WHEREAS, BG EAT members enrolled Buffalo Grove in the Mayor's Monarch Pledge and pass out milkweed seeds at the Farmer's Market and other local events.

**NOW, THEREFORE BE IT RESOLVED**, that the Buffalo Grove Park District Board of Commissioners, Cook and Lake Counties, by adoption of this Resolution, hereby extend our sincere appreciation and congratulations to the Buffalo Grove Environmental Action Team in recognition of it's 10th Anniversary of striving to improve our community's quality of life for generations to come.

Commissioner Reiner pointed out that early on, the Park District took on any park offered, but once Executive Director Mike Rylko took over he stopped accepting parks that were of no value or benefit to the community. Vice President Johnson congratulated EAT on their anniversary and said it is an honor to serve as their liaison.
