



DIRECT DEBIT TUITION PAYMENT AGREEMENT

Tuition payments will be divided into nine equal payments with the first payment due at registration. Payments will be debited on September 19, October 19, November 19, December 19, 2018, January 18, February 19, March 19 and April 19, 2019.

Electronic fund transfers that are denied due to insufficient funds will be charged a \$15.00 service fee by the Buffalo Grove Park District. If a payment is returned for insufficient funds, payment must then be resubmitted with the \$15.00 service fee in the form of cash, money order, credit card, check or cashier's check. If a parent/guardian is delinquent on a child's account, and does not submit payment within one week of the delinquency, the child will be removed from the program.

If you wish to change the form of payment from automatic withdrawal to credit card withdrawal, or to another account, you must notify the Buffalo Grove Park District office: Attention Robin Racusen in writing (forms are available at the Park District and on line at www.bgparkdistrict.org) five business days prior to the posting. There will be a \$5.00 fee charged for each change.
