



PRACTICE FIELD REQUEST

Attached is information concerning practice fields. To eliminate confusion, we require all coaches to submit their choice for a practice field. Your request will be processed and a field permit will be issued to you. When you receive the field permit, carry it with you to all your practices.

Included is a listing of all available fields with regard to age division. Please use these specific-sized fields when requesting a practice time. While the Park District recognizes that many coaches prefer to schedule fields based on location, regardless of size; many younger teams have a difficult time practicing on fields when an older group is practicing. Out of necessity, most of our fields are double-scheduled (two teams on a field at the same time.) Please request an appropriately sized field.

Practice fields vary in sizes and are not the typical size of game fields. Fields and goals may be down-sized depending on the park site and goals adjusted in various positions for practice purposes.

Fields are assigned on a first-come, first-served basis.

PLEASE NOTE:

Willow Stream will be CLOSED for practices in August. Chris Eckert will inform the coaches when it opens. (NO PRACTICES AT THIS TIME).

The Willow Stream soccer fields are our premier fields. You are expected to use extra caution while using these fields. Never practice in the rain or during wet field conditions. Rotate field use areas throughout practice and only use the goal mouth for shooting drills. Failure to follow the above rules will result in immediate loss of practice field privileges with relocation to an available field of the Recreation Manager's choice.
