## General Information

- This application is for review purposes only.
- Submission of this application does not mean your booth has been accepted into the fair. Approval notifications will be sent to each vendor via email.
- If your application is denied, your application and payment will be shredded. Booth fees are non refundable upon acceptance into the fair.

## Vendor Information

- Applications are handled on a first come, first serve basis.
- We will try to limit the number of vendors with a similar product in an effort to provide our patrons with variety while still allowing our vendors the opportunity for a successful show.
- Applicants are asked to submit 3 photos representative of their work with their application.
- We only allow one business per table.
- We will have a limited amount of non-retail spaces available for those interested in promoting a small business that does not fall under the traditional retail vendor category.
- We reserve the right to refuse vendors if we feel it would not be the right fit for our event.
- For direct sales participants - We will only accept one application for each direct sales product (31, Rodan & Fields, etc.). Duplicate vendors will be notified immediately and your application and fees will be shredded.
- All vendors are kindly asked to bring a door prize donation valued at a minimum of \$15 to be raffled off to our guests.
- In the unfortunate event of low vendor interest, we may be forced to cancel the fair. Applicants will be notified as soon as possible and all payments will be refunded.
- Each vendor will be given one free concessions item as well a bottle of water
- Additional information regarding the day of event details will be emails to vendors upon acceptance into the fair.

## Table space details and fees

- 8' table space - \$50
  - There is no depth to these spaces, only room for table and chairs
  - 2 chairs will be provided; however, tables will not.
- 10' x 10" booth space - \$125
  - There are no walls, barriers or pipe and drape to mark off spaces. Your space will be marked with tape.
  - 2 chairs will be provided; however, tables will not.

There are a limited amount of 8' tables available for rental at the cost of \$10 per table. Each 8' space can only accommodate one 8' table. Please note all spaces are approximate and we cannot guarantee exact dimensions. If you have specific needs please let us know on your application.
